Contract & Requirements

Turning Pointe Theatre Company Members and Karate World Competition Team (Commitment is vital for this ministry)

- Audition fees \$15.00 per student and a signed contract turned in by you and your parents.
- **Participants are required to raise \$350.00 per student or \$550.00 per family and can be paid in full or monthly payment: (\$35.00 for 1 student) and (\$55.00 for 2 students).**
- **All Company member are required to take and/or are financial responsible for Summer Intensive.**
- Copy of your Birth certificate / Passport on file for Missions Documents.
- Must be committed to study the required hours at TPCA.
- TPT will be your First commitment for class study and performances.
- (Any outside performances must be approved by director and not conflict with any TPT function.)
- All company members must take required summer camps at TPCA.
- (Any conflict must be approved by director.)
- Must show discipline in time management, arrive on time for class, rehearsal, and performances. (Continually late or missed class and rehearsals will signify your lack of commitment and will be asked to resign from the company.)
- Company member's responsibility to know class, rehearsal, and performance times.
- Any absentee from rehearsals or performances requires notification and reasonable excuse (family emergency, school function – lack of knowledge about a rehearsal is not acceptable). If you miss rehearsal before a show you will not perform...!
- Committed to serve the Lord through Prayer and Bible Study.
- Must be available for scheduled rehearsals and performances.
- *All Company Members Requirements: Worship/Production Class or Musical Theatre/Production Class*

Professional (16-99 yrs.): 6 hours of class discipline (1 summer camp intensive)

Apprentice (13-15 yrs.): 5 hours of class discipline (1 summer camp intensive)

Youth (10-12yrs): 4 hours of class discipline (1 summer camp intensive)

Kid's (5-9yrs): 3 hours of class discipline (1 camp)
